# Background

- 5th Swiss EPR Projectathon
- September 20-24, 2021, Eventforum Bern
- Legal basis: Federal Act of 19 June 2015 on Electronic Patient Record (EPRA)
- EPR system is slowly taking off now / some communities are certified, some still in the certification process
- Nursing homes must go online in April 2022



# Aims of the EPR Projectathon

- Organised by FOPH, IHE Suisse, eHealth Suisse. Technical provider: IHE Services Europe
- Technical aim: To have mature integration profiles and systems for the EPR implementation
- Cultural aim: Common development of IHE expertise over time / IHE community and «spirit»
- All «old» IHE profiles will be testable at PAT2021
- New profiles ready for testing regarding eVaccination, eTransition of Care, eAllergyIntolerance, Rad-Order, Lab-Order, eMedication and mHealth (FHIR standard)

# Participation conditions

- Registration in June 2021
- Contracting by IHE Services Europe, this mandated by eHealth Suisse
- Normally taking place at Eventforum Bern
- Registration fee: CHF 350 per vendor representant
- Fee includes testing, catering and participation at social event (if taking place)
- eHealth Suisse offers support for hotel search



# Special Covid situation

- Currently quite relaxed Covid situation in Switzerland
- Nevertheless border issue (border transfer)
- Choice of double strategy: We are preparing online testing event, in parallel we hope physical event is feasible during Projectathon week
- Only limited space available for physical event at Eventforum if social distancing needed (to be analyzed). At least one person of the participating team should be on site
- If no physical reunion possible in September, we will have a pure online testing event

- Main testing scope this year: Use cases eMedication, mHealth, eVaccinations and eTransition of Care

- No-peer-testing available during pre-Projectathon-test-phase and Projectathon itself
- At Projectathon **focus on peer to peer testing, group testing** and theme tracks
